ON DECEMBER 03, 1990, AT APPROXIMATELY 1543 HOURS, THIS DETECTIVE WAS CONTACTED BY OFFICER J. BASHITA OF THE CRIMINAL INTELLIGENCE UNIT OF THE NEW HAVEN POLICE DEPARTMENT, RELATIVE TO INFORMATION HE HAD RECEIVED ABOUT THE MURDER OF RICARDO TURNER AND LAMONT FIELDS. OFFICER BASHITA THEN RELATED THE FOLLOWING INFORMATION TO THIS DETECTIVE:

ON DECEMBER 02, 1990, HE WAS IN CONVERSATION WITH AN INFORMANT WHO TOLD HIM THAT THE WORD ON CONGRESS AVENUE WAS THAT AN INDIVIDUAL, KNOWN ONLY AS "BULLET" TO THE INFORMANT, WAS RESPONSIBLE FOR THE DEATHS OF TURNER AND FIELDS. THE INFORMANT NOTED THAT BULLET WAS DEALING NARCOTICS WITH RICARDO TURNER AND THAT TURNER HAD SOMEHOW "MESSED UP" AND THAT BULLET "DID HIM IN". THE INFORMANT STATED THAT BULLET WAS A LIGHT SKINNED BLACK MALE OR POSSIBLY HISPANIC MALE IN HIS TWENTIES. HE STATED THAT BULLET WAS STILL ACTIVELY INVOLVED IN THE SALE OF NARCOTICS IN THE CONGRESS AVENUE-HALLOCK STREET AREA AT THIS TIME.

THE INFORMATION SUPPLIED BY THE INFORMANT, AS WELL AS THE BRIEF DESCRIPTION OF THAT INDIVIDUAL KNOWN TO THE INFORMANT AS BULLET, IS CONSISTENT WITH THAT INDIVIDUAL WELL KNOWN TO THIS INVESTIGATOR AS MICHAEL CARDWELL, DATE OF BIRTH 11/20/68.

OFFICER BASHITA STATED THAT HE WOULD PURSUE THE INFORMANT'S KNOWLEDGE OF THE INCIDENT AND ATTEMPT TO SET UP AN INTERVIEW WITH THIS DETECTIVE IN THE VERY NEAR FUTURE.
